

PRESS NOTICE (With Extended Date)

1. The Officer Commanding, Construction Squadron, NSG , Manesar, Gurgaon, Haryana on behalf of the President of India, invites the bids from firms / contractors of repute in two envelop system for the following work :-

2. Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.

(a) Should have satisfactorily completed the works as mentioned below during the last seven years ending 31.12.2011

(i) Three similar works each costing not less than **Rs. 10.45 lakhs** or two similar works each costing not less than **Rs. 13.05 lakhs** or one similar work costing not less than **Rs. 20.90 lakhs**.

(ii) **Specialised agencies should have direct import license (direct importer of surface system) or they will have to submit proof / affidavit / MOU for using surface system from approved manufacturer/ direct importer of surface system.**

(iii) **Similar work means construction of synthetic Tennis Courts with Asphalt (Bituminous) Base and WBM sub base.**

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders.

3. Bid documents consisting of plans, specifications, the schedule of quantities of the various types of work to be done and the set of terms and conditions of contract to be complied with the contractor whose bid may be accepted and other necessary documents can be seen in the office of the Officer Commanding, Constn Squadron, NSG Manesar between hours of 0900 and 1300 hrs from **21.02.2012 to 28.02.2012** every day except on Sunday & Public Holidays. Bid documents, excluding standard form will be issued from this office during the hours specified above on payment Rs 500/- as cost of bid document. The last date of issue of bid documents shall be upto 1200 hrs on **06.03.2012**.

4. Applicant has to deposit earnest money of Rs 52,300/- in the form of Demand Draft/Pay Order of the schedule Bank issued in favour of PAO, HQ NSG, Payable at New Delhi alongwith tender documents.

5. Application supported by prescribed Annexure for eligibility, and financial bid shall be placed in separate sealed envelops each marked '**Eligibility Documents**', and '**Financial bid**' respectively. Both the envelops shall be submitted together in another sealed envelop. The bids will be received upto 1200 hrs on **16.03.2012** in the office of Officer Commanding, Constn Squadron, NSG Manesar. The envelops marked '**Eligibility Documents**' shall be opened by the Officer Commanding, Constn Squadron, NSG Manesar or his authorized representative in his office in the presence of intending bidders on the same day at 1230 hours. The time and date of opening of **financial bid** shall be communicated at later date.

(i) Pre-bid conference shall be held in the chamber of Chief Engineer, HQ NSG, at Mehram Nagar, Palam, New Delhi at 3.00 PM on **09.03.2012** to clear the doubt of intending tenderes, if any.

(ii) The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
