Note: - AC-I/II/III & Ranger-I/II posts are equivalent to the rank of Inspector/Sub Inspector/ASI/HeadConst/Const respectively.

2. As per the Recruitment Rules notified, these posts are to be filled by transfer on deputation from amongst the personnel holding analogous posts on regular basis and having two years working experience in the relevant field and they should be medically fit (SHAPE-I category). Further if the above mentioned ranks are not available in your organization then the equivalent rank personnel can be nominated for the said posts.

3. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization / department of the Central Govt. should not exceed five years.

4. Personnel while on deputation with the NSG would continue to draw the basic pay being drawn by them in their parent department and would be entitled to the following pay and allowances:-

- (a) Basic pay / DA as admissible in the scale of pay of the rank held in the parent organization.
- (b) Other allowances admissible to the Central Govt employees from time to time.
- (c) NSG allowance @ 25% of total emoluments (excluding HRA and CCA).
- (d) Concession of free ration according to Army scale and rent free family accommodation or HRA plus CILQ at the prescribed rates.

5. It is also intimated that Trade Special Pay if any admissible in the parent department will not be admissible in NSG as directed by MHA (Police Finance).

6. It is, therefore, requested that nominations of willing and suitable personnel may please be sent to this Directorate General along with their service particulars (Date of birth, Date of appointment in Govt service/Date of promotion to the present rank/Education/Details of major/minor punishments etc) and ACR grading for the last 5 years **by 30/09/2011.**
