Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.

They should have satisfactorily completed the following works in last 7 (seven) years ending last day of the month previous to the one in which tenders are invited. For this purpose, cost of work shall mean gross value of the completed work. This should be certified by an officer not below the rank of Executive Engineer or equivalent.

- (A) For CPWD enlisted contractors of appropriate class and those of appropriate list of M.E.S/BSNL/ Railways /State PWD (B&R)] in composite/ Building/ Buildings and Roads category having experience as prescribed hereunder or Specialized agency in the field of Designing, Engineering, Supplying, Installing/up-gradation of Advanced Eco Reactor (AER) Technology based STP":-
 - (i) Three similar works each of capacity 40 KLD or each costing not less than Rs. 46.85 Lakhs.
 - (ii) Two similar works each of capacity 60 KLD or each costing not less than Rs. 70.28 Lakhs.
 - (iii) One similar work each of capacity 80 KLD or each costing not less than Rs.93.71 Lakhs.

Similar work shall mean work of "Designing, Engineering, Supplying, Installation /up-gradation of Advanced Eco Reactor (AER) Technology based STP" and satisfactory completion shall mean "works completed within stipulated time or extended time without levy of compensation for delay".

(B) For CPWD enlisted contractors of appropriate class and those of appropriate list of M.E.S/BSNL/ Railways /State PWD (B&R)] in composite/ Building/ Buildings and Roads category in association with Technology partner of Advanced Eco Reactor (AER) Technology based STP OEM or Authorized firm from OEM. The contractor shall fulfill the eligibility criteria prescribed hereunder as per 1(B)(i) and Technology Partner shall fulfill the elegibility criteria prescribed hereunder as per 1(B)(ii).

Note: The Main Contractor shall also be required to upload /submit the MOU in prescribed pro-forma with "Technology Partner of Advanced Eco Reactor (AER) Technology based STP OEM or Authorized firm from OEM" along with work experience certificate for associated firm as required.

(i) Three works of "Construction of STP/ Building work" each of capacity 40 KLD or each costing not less than Rs. 46.85 Lakhs or two works of "Construction of STP/ Building work"

each of capacity **60 KLD** or each costing not less than **Rs. 70.28 Lakhs** or one work of "Construction of STP/ Building work" each of capacity **80 KLD** or each costing not less than **Rs.93.71 Lakhs** in last 7 years ending last day of the month previous to the one in which the tenders are invited.

(ii) Experience of work for associate firm with which contractor desired to associate i.e. "Technology partner of Advanced Eco Reactor (AER) Technology based STP OEM or Authorized firm from OEM" having experience of three similar works each of capacity 40 KLD or two similar works each of capacity 60 KLD or one similar work each of capacity 80 KLD in last 7 years ending last day of the month previous to the one in which the tenders are invited.

Similar work for 1(B)(ii) shall mean work of "Designing, Engineering, Supplying, Installation, Testing and Commissioning of Advance Eco Reactor (AER) Technology based STP" and satisfactory completion shall mean "works completed within stipulated time or extended time without levy of compensation for delay".

Experience of only Govt. Sector shall be considered with valid experience certificates of works having been completed satisfactorily, and the work completion certificate shall be issued by an authority of the rank not below the rank of Executive Engineer.

Note: The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion up to the previous day of last date of submission of bids.

- 2. The bid can only be submitted online to the Sqn Commander (Engg), 27 Special Composite Group, National Security Guard, Nedungundram, Kolappakam, Chennai -600127 by uploading the mandatory scanned documents. The intending bidder must read the terms and conditions of CPWD-6 & 7 carefully as amended/ modified and uploaded in the bid documents of this tender. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 3. This information and instructions for bidders posted on website shall form part of bid document.
- 4. The contractor submitting the bid should read the schedule of quantities special conditions, particular specifications and other terms and conditions given in the NIT and drawing. The bidder should also read the terms and conditions of the CPWD, General Condition of Contract for Constriction Works 2023 with all correction slips issued upto last date of submission of bid, which is applicable as Government of India publication. However, provision included in the bid documents shall prevail over the provision contained in the standard form. The set of drawings and NIT will be available with the office of SC(Engg) 27 SCG NSG, Chennai. The contractor may also visit the site of work and make himself acquainted with the site conditions before tendering.

The conditions which already form part of the tender are specially brought to his notice for compliance while filling the tender.

- 5. The successful tenderer shall be required to deposit a performance guarantee of 5% (Five Percent) of accepted tendered value within seven days of issue of letter of Intent. This period can be further extended by Engg-In-charge upto a maximum period of 7 days on the written request of the contractor, subject to payment of late fees @ 0.1% per day of Performance Guarantee amount. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F', including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The earnest money deposited along with bid shall be returned after receiving the aforesaid performance guarantee.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 7. Contractor can upload documents in the form of JPG format / PDF format.
- 8. Contractor must ensure to quote percentage above or below the estimated cost.
- The Technical Bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated to them at a later date.
- 10. The contractor whose bid is accepted will also be required to furnish original document along with attested /certified copy of each of the applicable Licenses/ registrations or proof of applying for obtaining

labour licenses/registration with EPFO, ESIC and BOWC Welfare Board and Program Chart (Time and Progress) within the period specified in schedule "F".

- 11. The reimbursement of EPF & ESI contributions paid by the contractor on the part of employer is to be made on submission of documentary proof of payment provided the same is in order.
- 12. GST which shall mean Goods and Services Tax- central, state and inter-state GST or any other Tax applicable in respect of inputs procured by the contractor for this contract shall be paid by the contractor and Government will not entertain any claim whatsoever in respect of the same. However, component of GST at the time of supply of service (as provided in CGST Act 2017) provided by the contract shall be varied only if by any notification of the Govt. it is changed from that applicable on the last date of receipt of tender including extension, if any.
- 13. Earnest Money in the form of Demand Draft/ Banker Cheque/ FDR/ Pay order/ Deposit at call receipt/ Bank Guarantee (drawn in favor of RPAO (CISF) Chennai payable at Service Branch Chennai) shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The physical EMD shall be dropped in the box placed in front of the office of TC (Civil) at 27 SCG NSG, Chennai by 1100 hours on 11/03/2024. In case EMD is not found in the box at time of opening of tender, online bid of such bidder shall be treated as cancelled without any notice.
- 14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
- 15. List of documents to be scanned and uploaded within the period of bid submission:-
 - Scanned copy of EMD in form of Demand Draft/FDR/Pay Order/Bankers Cheque/ Deposit at call receipt/ Bank Guarantee of any scheduled Bank against EMD.
 - Certificate of Registration/ Enlistment order of the Contractor of appropriate category (In case applicable).
 - Experience certificate of having successfully completion of required works as per eligibility conditions for Main Contractor as well as for Associated Firm, as the case may be. (Sample proforma at Page No. 58)
 - iv. GST Registration Certificate (of the State in which the work is to be taken up i.e. Tamilnadu), if already obtained by the bidder.
 - If the bidder has not obtained GST registration as applicable (of the State in which the
 work is to be taken up i.e. Tamilnadu, or as required by GST authorities) then he shall
 scan and upload following under taking along with other bid documents.

"If work is awarded to me, I/we shall obtain GST registration Certificate as applicable, within one month from the date of receipt of award letter or before release of any payment by NSG, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by NSG or GST department in this regard.

- vi. EPF and ESIC Registration Certificate.
- vii. Central /State Govt. Department issued Electrical license of contractor or MOU with electrical license holder contractor enlisted in appropriate class in CPWD, M.E.S., BSNL, Railways or State PWD eligible to bid for E&M component individually (Rs 12,00,000/-) (Proforma of MOU with electrical agency is as per Page 52 to 54)
- viii. MOU with associated agency (if applicable) as per para 1(B)(ii) be uploaded as per Pro-forma of MOU at page No 55 to 57).

Note: - Any shortfall of documents as mentioned above shall not be sought from contractor after period of bid submission or extension, if any. The above mentioned documents need to be scanned and uploaded carefully on e-tender portal.
